#### 2022 ANNUAL GENERAL MEETING

More than 80 people attended AJEFA's Annual General Meeting held on June 3, 2022 at La Cité francophone in Edmonton. Among the activities, there was a workshop on Indigenous realities with Rénald Rémillard, a panel on restorative justice with the Honourable Justice Anna Loparco, and a presentation on Indigenous rights with Karen Restoule. The Jean-Louis-Lebel Award was presented to the Honourable Justice Anne Brown for her work in improving access to Frenchlanguage services in the Provincial Court (now Alberta Court of Justice).



### A WORD FROM THE PRESIDENT OF AJEFA

On behalf of the *Association des juristes d'expression française de l'Alberta* (AJEFA), I am proud to present you this message in AJEFA's 2022-2023 Annual Report. You will find more information on our many projects, events, programming and services in the following pages.

As you may be aware, AJEFA has been working for over 30 years to facilitate access to legal services in French in Alberta. Today, there are 110 lawyers, mediators, arbitrators, etc. and 48 law students that make up our membership.

Due to a growing demand for access to justice from French-speaking litigants in 2022, AJEFA is very pleased that the following proceedings took place in French: 25 criminal proceedings in the Court of King's Bench of Alberta, and eight trials and hearings in the Provincial Courts of Alberta. Additionally, in 2023, there were two appeals in the Alberta Court of Appeal, and 13 trials and hearings scheduled for the Alberta Court of Justice. Following this trend, the number is likely to increase in the near future due to the growing demand for legal services in French.

On July 28, 2022, I also had the privilege of representing AJEFA in Edmonton at the National Consultation on Official Languages with the Minister of Canadian Heritage, the Honourable Ginette Petitpas Taylor. Her goal was to develop a new action plan for official languages. During this consultation, I presented a general picture of access to justice in French. On August 25, 2022, I also represented AJEFA at the Closing Summit of the National Consultations on Official Languages in Ottawa.

On February 23, 2023, AJEFA acquired political gains with the Law Society of Alberta as a result of its determined and persistent advocacy. These gains include amending the sections of the Code of Professional

Conduct requiring Alberta lawyers to inform their clients of their language rights.

At the same time, AJEFA continues to work with Alberta Justice through the Justice in French Advisory Committee, with representatives from the Government of Alberta, the Court of Appeal, the Court of King's Bench, the Alberta Court of Justice and the ACFA. On March 14, 2023, I had the opportunity to meet with the Honorable Tyler Shandro, Minister of Justice and Solicitor General of Alberta, as part of Alberta Francophonie Month.

AJEFA is also a member of a national federation, the *Fédération des* associations de juristes d'expression française de common law inc. (FAJEF). As President of your board, I participated in all the national meetings. Recently, FAJEF applied for intervener status before the Supreme Court of Canada in a criminal case involving language rights.

In conclusion, I would like to thank all the members of the Board of Directors and the staff of the AJEFA office as well as all the volunteers for their work and commitment. Together, we still have a great deal of work to do in order to continue to advance the cause of accessing justice in French, which is our right as Francophones in a minority situation belonging to a linguistic, national and constitutional community.

# NEW LEGAL INFORMATION GUIDE FOR 2SLGBTQI+ YOUTH

The official launch of *Quels sont mes droits à l'école?* (What are my rights at school?) was held on May 6, 2022 in Edmonton. This project results from a collaboration with the Comité FrancoQueer de l'Ouest. The guide is an informational document that addresses many issues such as the creation of Gay-Straight Alliances. It also discusses privacy rights, anti-discrimination and reasonable accommodations in schools.

AJEFA would like to thank Pauline Blais, a lawyer in Edmonton, for all her volunteer work on the guide and for facilitating workshops for students and parents afterwards.

# FRAUD PREVENTION FOR SENIORS

168 seniors from Bonnyville, Calgary, Edmonton and St. Isidore participated in face-to-face and online interactive workshops on fraud prevention thanks to the invaluable collaboration of the local circles of the Fédération des ainés franco-albertains. This project was funded by the Government of Canada through the New Horizons Program.

# RETURN OF THE DEBATE COMPETITION — FEBRUARY 3 AND 4 AT CAMPUS SAINT-JEAN (EDMONTON)

The *Sommet des débats* (debate competition) reached a record number of participants this year: 36 high school students from eight high schools in Calgary, Edmonton, Lethbridge, Red Deer, Sherwood Park and St. Albert, including the winning team from Archbishop MacDonald (Edmonton). This event was funded by Canadian Heritage and the Government of Alberta.

#### **NETWORKING**

For the first time, AJEFA members were invited to year-end celebrations to meet and sing some Christmas carols. Twenty AJEFA members gathered at President Elsy Gagné's home on December 8<sup>th</sup> in Calgary and more than thirty members stopped by Executive Director Denise Lavallée's home on December 15<sup>th</sup> in Edmonton

On March 23, 2023, 12 law students in the French Common Law Certification Program at the University of Calgary and the University of Saskatchewan joined a dozen lawyers in Calgary for a conference on language security and for networking. On March 24, 2023, 15 University of Alberta law students and 20 AJEFA lawyers participated in a networking event at Campus Saint-Jean in Edmonton.

#### **OUR STUDENT VOLUNTEERS**

AJEFA has renewed its partnership with the Pro Bono Students Canada (PBSC) for the 2022-2023 academic year. Matthew Gray 1 and Tasia Ntwari 2 from the University of Calgary's Faculty of Law led legal information workshops for AJEFA. #### LAW STUDENT SCHOLARSHIP

In 2014, AJEFA created an endowment fund with La Fondation francoalbertaine which has grown and generated enough interest to offer a \$2,000 scholarship annually since 2022. This year's recipient is Isabelle Reynolds, a 3<sup>rd</sup> year student at the University of Calgary in the French Common Law Certificate Program.

# LEGAL INFORMATION BOOTHS AND WORKSHOPS

1,042 people were reached through 45 workshops on new topics such as the *Freedom to Care Act*. Of these, 475 were students from Brooks, Calgary, Edmonton, Lethbridge, and St. Albert who participated in workshops on 2SLGBTQIA+ youth rights, consent and careers in justice.

AJEFA also participated in two national projects, Sexual Harassment in the Workplace and Immigration Labour Law by organizing four workshops and developing a learning module. AJEFA hosted nine information booths, mostly in Calgary, including a career fair at École de la Rose sauvage.






#### LANGUES UTILISÉES / LANGUAGES USED




