# MESSAGE FROM THE PRESIDENT Jean-Jacques Beauchamp The Honourable Justice Russell Brown

On behalf of the Association des juristes d'expression française de l'Alberta (AJEFA – French-speaking Legal Professionals Association of Alberta), I present this annual report to the 141 members of the Association and the community.

As you know, the pandemic had a direct effect on all of our activities between April 1, 2021 and March 31, 2022. Our annual gathering had been meant to be in person on the 24 of September, but instead took place online with over 50 participants. Nevertheless, we had the privilege of hosting the Honourable Justice Russell Brown of the Supreme Court of Canada who offered an inspiring account on the topic of bilingualism, among other things. We also had the opportunity to honour Mr. Jean-Jacques Beauchamp, a pioneer in the field of restorative justice in Alberta.

In 2021-2022, consultation services offered by the Alberta Legal Information Centre (Centre) took place by telephone or email, with the exception of Public Notary and Commissioner for Oaths services. The Centre offered 1,266 remote consultations, including 282 in-person Notary Public and Commissioner for Oaths services.

Thanks to our numerous partners, AJEFA presented 43 online legal information workshops by videoconference to 1,849 participants, 1,274 of whom were youth. Many workshops were developed on subjects such as sexual harassment in the workplace, 2SLGBTQIA+Youth Rights, and asylum seekers, among others.

In 2021-2022, AJEFA was extremely active in advocacy. Firstly, the Justice in French Advisory Committee, composed of representatives of the government of Alberta, of the Court of Appeals, of the Court of Queen's Bench, of the ACFA as well as the AJEFA, met on three occasions to discuss and further multiple files. The objective of this committee is the improvement of access to justice as well as the capacity to offer legal services in French.

Additionally, online and in-person meetings took place between the AJEFA and the Fédération des associations de juristes d'expression française de common law inc. (FAJEF), with the goal of defending and promoting access to justice in French in all provinces and territories of Canada.

Finally, the Honourable Chief Justice Mary Moreau of the Court of Queen's Bench announced a pilot project regarding the use of French in proceedings before the Court had become officially permanent as of the end of the month of February 2022. This pilot project offering services in French in court is of great importance to AJEFA and to everyone subject to the court system, as it is de facto part of the application of linguistic rights of francophones in Alberta and fosters the rule of law in Canada.

AJEFA continues to raise awareness with the Law Society of Alberta on issues pertaining to linguistic rights so as to assure that all French-speaking defendants can exercise the rights accorded to them by section 530 of the Criminal Code of Canada, and do so without need of an interpreter.

I must thank the members of the administrative council and the AJEFA office staff for their commitment and devotion during my first year on the council as President of the AJEFA. I'm excited to continue the work that is already underway and to see you in person so as to maintain our professional cooperation as well as to share in our passion for Francophonie! Thank you for the trust you have placed in me!

# LEGAL INFORMATION BOOTHS AND WORKSHOPS

More than 500 members of the public were informed, mostly by videoconference, on various areas of law, notably power of attorney, asylum seekers and return to work post-COVID. AJEFA participated in two projects with a national scope relating to sexual harassment in the workplace and employment law as it pertains to immigration by organizing six workshops and training sessions for over 200 participants. A virtual and in-person booth was organized as part of a newcomer's welcome activity in Calgary and in Edmonton.

## HONOURABLE JUSTICE VITAL OUELETTE RETIRING

More than 25 legal practitioners and members of the community came together April 22, 2021 to celebrate the honourable Justice Vital Ouellette's retirement from Court of Queen's Bench of Alberta. A native of St. Paul, Alberta, Justice Ouellette has been very active in the French-speaking community of Alberta, notably having served as president of AJEFA from 1998 to 2001, president of the Conseil scolaire Centre-Est, and as president of the board of governors of La Fondation franco-albertaine. He has received numerous awards for excellence, including the Jean-Louis-Lebel award from AJEFA in 2013.





### CALGARY OFFICE

For the first time since its founding in 1990, AJEFA has an office in Calgary! As of February 1, 2022, the Alberta Legal Information Centre offers on-site services in Calgary, sharing offices with the Centre d'accueil des nouveaux arrivants francophones (CANAF). Legal Information Officer Florentine Ngarambe has been carrying out phone consultations and welcoming clients needing Commissioner for Oaths or Notary Public services. We anticipate that all in-person consultations will resume in 2022-2023.

### **LEGAL INFORMATION FEATURES**

Thanks to a partnership with Le Franco newspaper and Radio Cité, AJEFA published five legal columns and was featured in radio information interviews in a variety of areas of the law, including family, employment, immigration, landlord/tenant and language rights.

### AJEFA SCHOLARSHIP

In 2021-2022, AJEFA announced the creation of its first scholarship for legal studies in French. In 2014, AJEFA created an endowment fund with the Fondation franco-albertaine which has grown and generated enough interest in 2022 to provide a \$ 2,000 scholarship.

Applicants must be enrolled in a law program at the University of Calgary or the University of Alberta and have taken and/or be enrolled in at least one law course in French. Applicants must demonstrate their involvement in the francophone community and their intention to practice law in French in Alberta.

The very first scholarship recipient, Brenna Haggarty, is currently enrolled in the French Common Law certification program at the University of Calgary and is a graduate of Campus Saint-Jean.




